

## Our commitment



### as an authorised HVP company

#### Säker Vatten Installation Industry Regulations

Our company is committed to working in accordance with valid industry regulations for Säker Vatten Installation. This means that when installing to execute and follow industry regulations, employ staff with industry authorisation, and to carry out the checks and the documentation included in the industry regulations.

#### **Training of Personnel**

Our company commits through this undertaking to train all fitters, supervisors and company managers who work with HVP installations in current Säker Vatten Installation industry regulations.

#### **Marketing and Logo**

As a HVP company, we are committed to use the logo for an authorised HVP company in compliance with instructions and in accordance with good marketing practice. The logos can for example be used on printed matter, websites, cars, etc., according to applicable Säker Vatten Installation industry regulations.

#### **Code of Conduct**

We commit to comply with Säker Vatten AB's Code of Conduct for authorised HVP companies, *see annexe* 1:2 in the agreement, note that the annexe must be signed.

The Code of Conduct is intended to raise the level of credibility of a HVP company in the industry and to our surroundings.

#### Cooperation with the Swedish Tax Agency

Our company/branch is aware that Säker Vatten AB collaborates with the tax agency to prevent economic crime. Among other things, we check continuously that as an authorised HVP company, you satisfy the requirements for F-tax and VAT.

#### **Checks and Sanctions**

With this commitment, this company is bound to assist with the checks included in the industry regulations or the requirements for authorisation. We are obliged to rectify the defects that may arise during the checks within a reasonable period of time.

We are obliged to give feedback to Säker Vatten when requested and continuously check that the information on your company is current.

Säker Vatten AB can come with sanctions if an authorised HVP company does not comply with industry regulations. Sanctions may mean a company is stripped of its authorisation.

#### **Information Obligations**

As professionals, we are required to stay updated of changes in industry regulations and other current information sent out by Säker Vatten and inform our employees on these.

#### **Fees and Charges**

Our company accepts the applicable fees such as Säker Vatten AB decides will apply for the authorisation of HVP companies according to Säker Vatten Installation industry regulations.

#### **Membership in HVP Authorisation**

Through its authorisation, our company will become a member of VVS-auktorisation, a non-profit association that owns Säker Vatten AB. As a member of VVS-Auktorisation, we can engage at various levels, such as at annual general meetings or other association meetings.

#### **Commitments in Case of Changes**

If industry regulations or conditions of authorisation are amended, which will be announced in good time, the authorised HVP company must give notification of their non-acceptance of the terms at least one day prior to the changes coming into force, thereby terminating the company's authorisation. No response will be interpreted as the change being accepted.

#### Code of Conduct for authorised HVP company

The Code of Conduct is designed to ensure that the quality of authorised HVP companies is the highest possible and in accordance with client expectations. It is therefore important that all authorised companies stand behind the Säker Vatten Installation industry regulations and the associated Code of Conduct.

#### Fees 2020

These are the membership fees and service charges for different categories of companies for 2020. Entry fee is a one time fee to be paid only when joining. Membership fee and Service charge payable annually starting from entry.

I hereby consent to this personal data being processed by Säker Vatten as controller of personal data in respect of the processing (see contact details below to the data protection officer) aimed at enabling Säker Vatten to process an application to become an authorised building services installations company. I am also aware that, in order to apply for authorisation, Säker Vatten must be provided with the requested personal data and that authorisation will not be granted if I fail to provide Säker Vatten with such personal data. I am also aware that I may, at any time whatsoever, revoke my consent to the processing, but without such affecting the legality of the processing that has taken place based on consent prior to withdrawal of my consent.

Säker Vatten will archive the provided personal data as such time as the personal data relates to you, the holder of valid training in Safe Water installation, or belongs to an authorised building services installations company (provided you do not withdraw your consent prior thereto in accordance with the preceding sentence) and will thereafter delete the data without unnecessary delay. You are entitled to request that Säker Vatten afford you access to - and rectification or deletion of – your personal data or limitation of processing concerning you; you are entitled to object to processing and are entitled to data portability (i.e. to obtain your personal data and to transfer such data to another controller of personal data).

In the event Säker Vatten accepts the application to become an authorised company, the company undertakes to take all necessary measures to inform affected persons regarding Säker Vatten's processing of data concerning the company's employees, and to obtain necessary consents for such processing. Such information must, as a minimum, include information stated in this information text as well as all other information which Säker Vatten specifically states or which is required in accordance with legislation in force from time to time. At the request of Säker Vatten, the authorised companies must be able to substantiate that information in accordance with the information text has been disclosed to relevant individuals. To the extent relevant individuals present comments to the authorised companies regarding Säker Vatten's processing, the companies shall immediately notify Säker Vatten of such comments. Companies shall also notify Säker Vatten in the event affected individuals are no longer employed at the authorised company.

If you consider the processing of your personal data contrary to applicable personal data legislation you have the right to submit a complaint to the competent supervisory authority; The Data Inspectorate, Drottninggatan 29, 111 51 Stockholm.

## Important to remeber



## While we are processing your application

#### When applying for authorization from Säker Vatten

We are happy that you want to authorize the company and train your staff in Safe Water and in this way help to protect the industry against water damage and personal injury.

## The following applies before the authorization is complete and approved by Safe Water

- You cannot enter into an agreement to carry out the work in accordance with Säker Vatten industry rules,
- nor start an installation in accordance with Safe Water's industry rules before
- the authorization is complete.
- You may not market yourself as authorized to clients.
- You must not write on the website that you are an authorized company
- You may not copy the Safe Water logo and use it on the website or other
- marketing
- You may not update a previously installed installation and write a certificate afterwards.

If Säker Vatten detects a marketing violation with Säker Vatten brand so measures are always taken with suspension and exclusion as a consequence.

That as an applicant company is not allowed to market itself as an authorized company before the authorization is confirmed from Safe Water means that the company will not be able to authorize themselves for 1 year from the cessation of unauthorized marketing.

Misleading and incorrect marketing is a violation of the Marketing Act and that using Safe Water's logotype is not allowed trademark infringement.

#### When the authorization is complete and approved by Safe Water

When the authorization for your company is complete, Safe Water will send out a welcome pack containing diplomas, brochures and stickers
